Donee is the elder Daughter of the Donor. They have utmost mutual love and affection for each other.

The Schedule Property formed part of the ancient ancestral Estate of late Raja Vyricherla Narayana Gajapathi Raju who is the father of the Donor. During his life-time he (the said Sree Raja Vyricherla Narayana Gajapathi Raju) executed his Last WILL dated 16-04-1938 in respect of his vast Estate and the same was registered as Doc. 4. 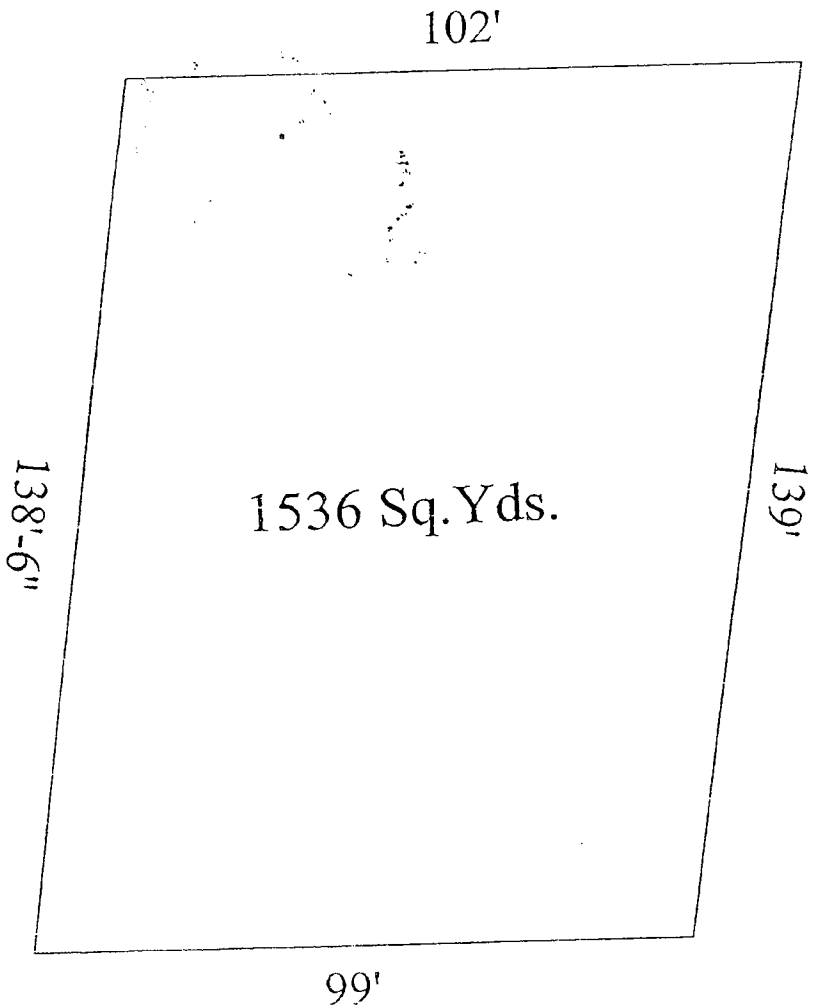

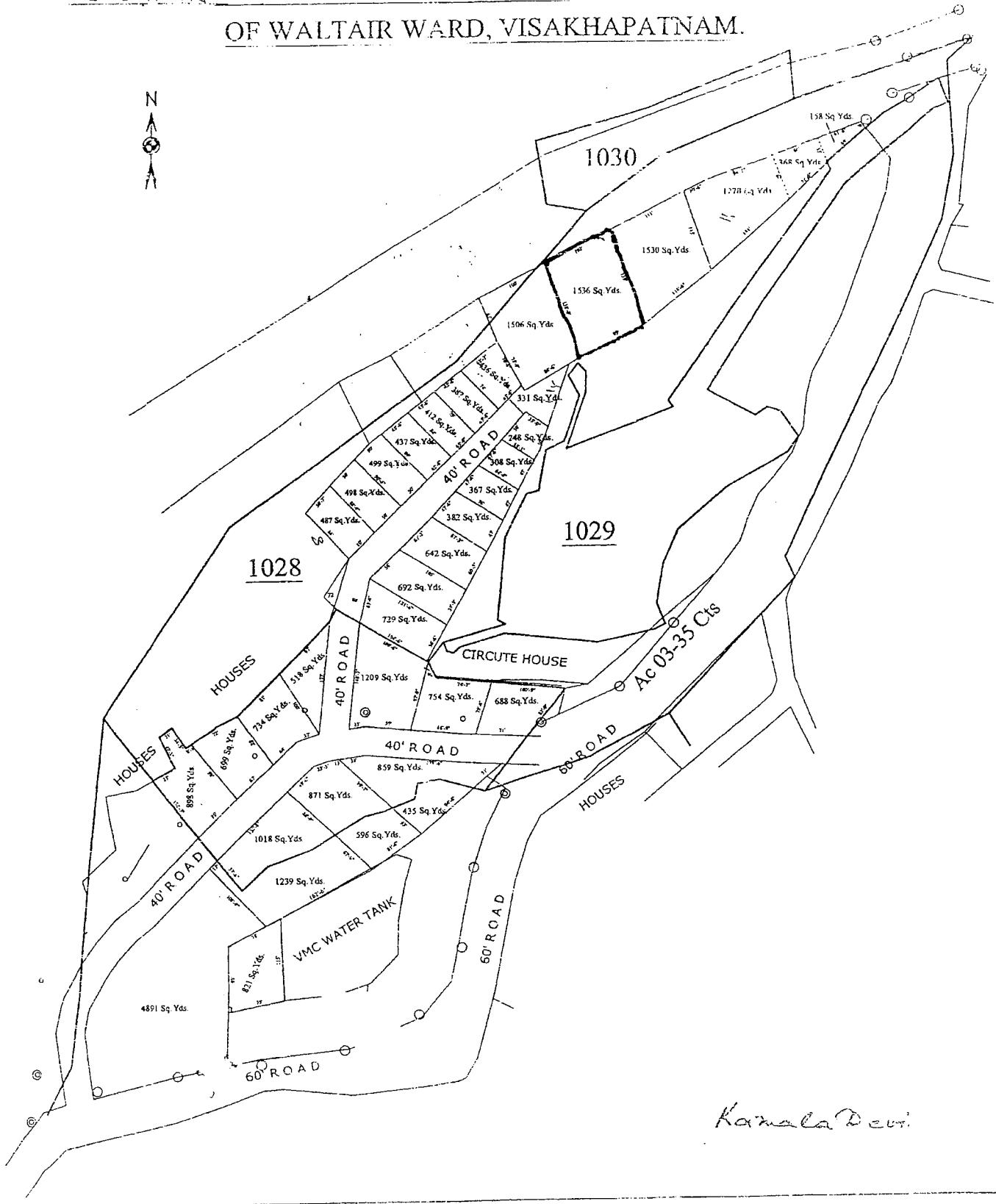

OF WALTAIR WARD, VISAKHAPATNAM.









